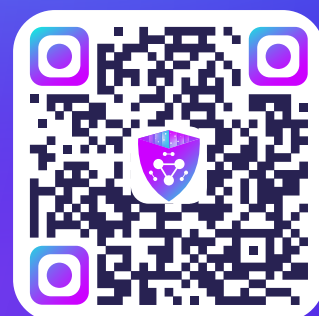

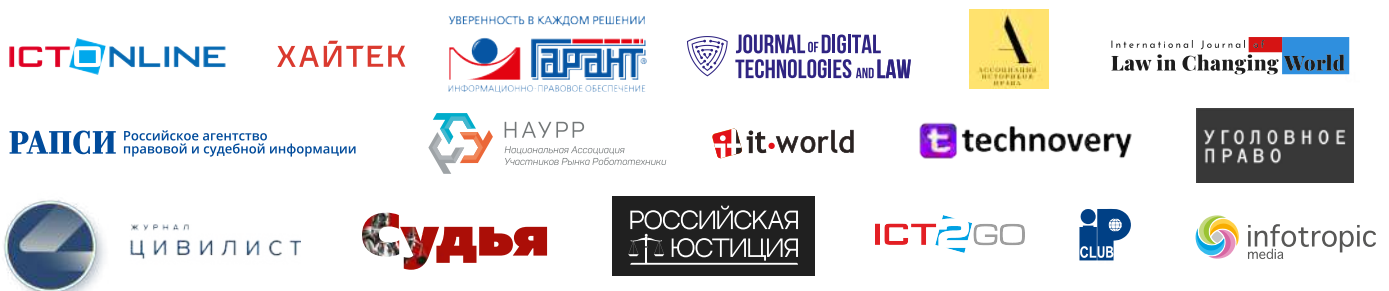

# REQUIREMENTS TO ARTICLES



The Conference Program Committee invites the works of predominantly academic character, not published before and not submitted to other conferences, containing original results. The submitted text must strictly comply with the Conference topic and reflect the results of theoretical and/or experimental research.



The works of the Conference shall be published based on reviewing and competitive selection. The Program Committee may accept full papers (1 print unit, or 40,000 printed characters, including spaces), brief reports (0.5 print units), or extended report theses (up to 0.25 print units). The maximal number of co-authors of one paper is three. The maximal number of works from one author is two.



A participant may submit a paper for the Conference and submit an extended full paper for the partner journal. Information about the partner journals is placed on the Conference website at <https://digitaltechnologiesandlaw.org>. The decision on the publication in the partner journal is taken by the journal Editorial Board based on reviewing the submitted articles by the Program Committee. You may contact the partner journals' Editorial Boards for more information.



Each article must have an abstract and key words in the Russian and English languages. When submitting an article, please specify the organizations where all authors work/study, as well as contact details of one of the authors.



It is recommended to use foreign literature sources. Not more than 30% of sources may be those published before 2019. Articles with incorrect borrowings and less than 75% of uniqueness will not be accepted for publication. Each manuscript shall be checked for potential incorrect borrowings with "Antiplagiat" system.

The article should be formatted in compliance with a template placed on the Conference website at <https://digitaltechnologiesandlaw.org>.

The article is submitted electronically, in a **docx format**.

The file with the text of the article should be titled as follows:

AuthorsSurnames\_article, for example, **Ivanov\_Petrov\_article.docx**

# REQUIREMENTS TO PRESENTATIONS



The Conference Program Committee expects presentations to the reports of the offline participants. All presentations will be uploaded to the Conference official website at <https://digitaltechnologiesandlaw.org> for open access.

## Recommendations for making presentations:



The presentation file must be formatted in strict compliance with the template.



The presentation should be not longer than 10-12 slides, as a rule.



The text of the presentation should be of illustrative character and be given as theses



A large amount of text in the presentation is not welcomed.



The use of icons in the presentation is encouraged. The use of frivolous images or animation is not allowed.



Legends to graphs and theses should be brief, on-point, and grammatically correct.

The presentation should be formatted in compliance with a template placed on the Conference website at <https://digitaltechnologiesandlaw.org>.

The presentation is submitted electronically, in a **pptx format**.

The file with the presentation should be titled as follows:

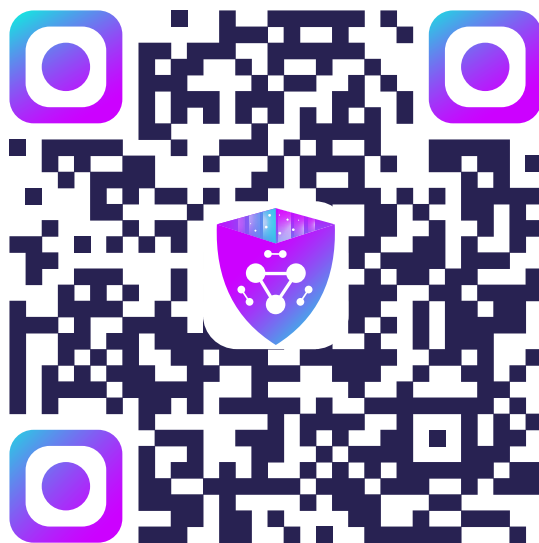
